Search System Improvements

Concepts important to injury research and prevention are often known by several terms. Thus a comprehensive search can be difficult. For example, baby walkers are also known as babywalkers (leaving out a space makes a difference in searching), infant walkers, youpala, etc. Driving under the influence of beverage alcohol is labeled drink driving, drunk driving, DUI, DWI, drinking and driving, etc. Now, the advanced search feature contains an index search option. While not yet an index search in the true sense, the new option uses the SafetyLit thesaurus to allow a search using *any single* synonyms for a concept to find ALL articles that are about ANY of the synonyms. Using a simple textword search would require searches using each of the individual synonyms for each concept and awareness of all possible synonyms.

SafetyLit Archive now contains more than 100,000 articles.

Last week the contents of the SafetyLit database exceeded 100,000 articles.
